Membership Disclaimer/Hold Harmless

In consideration of permission to use the property, facilities and services of the Montgomery County Family YMCA (the "YMCA"), such use including, but not limited to, use of the YMCA's facilities or equipment, participation in YMCA programs or activities, and observation of any of the foregoing, I do hereby agree:

1. Release and Waiver of Liability

For myself and my heirs, assigns, personal representatives, executors and administrators to waive, release, and forever discharge the YMCA and its respective directors, officers, employees, representatives and members (the "Releasee") from liability for any loss or damage and from any rights, claims or demands therefore which I have or which may hereafter accrue to me arising out of injury to my person or my property incurred in connection with my use of the property, facilities or services of the YMCA, whether such damages are caused by the negligence of the Releasees or otherwise.

2. Assumption of Risk

That I bear sole risk of injury resulting from my use of the property, facilities and services of the YMCA. Hereby, I assume full responsibility for any risk of any bodily injury, death or property damage arising from such use, whether caused by the negligence of the Releasees or otherwise.

3. Indemnification

To indemnify and hold harmless the Releasees and each of them from any loss, liability damage or cost they may incur in connection with my use of the property, facilities and services of the YMCA, whether cause by the negligence of the Releasees or otherwise.

4. Safety Procedure

For the safety of others, especially children, all new and renewing members will be referenced against the Iowa Sex and Violent Offender Registry. It would then be the prerogative of the Montgomery County Family YMCA to further investigate if necessary.

Photo Release

The Montgomery County Family YMCA and YMCA of the USA occasionally assigns a photographer to videotape and/or take photos of our members and participants engaged in various activities. Some of these videos and photos are used in YMCA marketing materials, ads, or brochures. I hereby give my permission and consent, now and for all time to make, reproduce, edit, broadcast, or rebroadcast any video film, footage, sound track recording, and photo reproductions of me and/or my narrative account of my experiences at the Montgomery County Family YMCA, for publication, display, sale or exhibition thereof in promotions, advertising and legitimate business use without any compensation to, and/or claim, by me. I may or may not be identified in such reproductions; however I shall not be stated by name to have endorsed any particular commercial products or commercial services.

Membership Agreement

All members are required to present a current, valid YMCA membership card for identification when using the YMCA's facilities and programs. Membership cards are not transferable to other people. As a member of the YMCA, you are agreeing to follow the policies, procedures, and appropriate behaviors for the safety and comfort of all members and guests.

Sex Offender Screening

The YMCA conducts regular sex offender screenings on all members, participants, and guests. If a sex offender match occurs, the YMCA reserves the right to cancel membership, end program participation, and remove visitation access.

Membership & Admission Policy

Membership at the Montgomery County Family YMCA and admission to its facilities and programs is a privilege, not a right. The Montgomery County Family YMCA reserves the right to deny, suspend or revoke the membership of any person whose behavior, whether on or off the YMCA premises, is judged by the Board of Directors either to be in conflict with the welfare of the YMCA patrons or staff, or in violation of the Montgomery County Family YMCA mission, as expressed in the mission statement found in the YMCA's promotional materials and by-laws. The Montgomery County Family YMCA has established a written procedure for notice and hearing in advance of suspension or revocation of membership, and a method of appeal of the determination to the YMCA's Board of Directors. The YMCA's Chief Executive Officer is responsible for implementation of this policy. Membership cards must be surrendered at termination. If your membership should lapse beyond 30 days, you will be required to pay the reinstatement fee again. The YMCA recommends consulting a physician prior to beginning any exercise program. I understand that all exercise and participation is done at the risk of the member and I agree to hold the YMCA and its employees harmless from loss of expense related to injury or loss of property. **I understand that this membership is non-refundable.**
